  even after giving concession, all members discussed the issue and felt that in special circumstances when
  needed can provide lg free of cost.
- Secretary informed all members about our institutional policy for hepatitis B vaccination which has been
  provided free of cost to everyone. All members asked the ICN to keep strict vigil on this issue.
- Gap report from value-added consultancy was discussed and decided to follow strictly hand hygiene, BMW segregation practices and also suggest the infection control team to educate the HCWs.
- Secretary bought to the notice to increase to number of ICN/liaison nurse and it was decided to discuss this
  issue with the management.
