

1. Our earlier submitted fee structure stand modified to this extent.
2. The above fee structure is subject to any further order which may be passed by the Hon'ble Supreme Court, Hon'ble Patna High Court or any competent authority. In such case, their decision shall be applicable and the fees will be re-revised accordingly.
3. The fee may also change as per the order of the Educational Fee Fixation Committee, Bihar.
4. NRI Tuition fee is to be paid either in USD or as per current equivalent amount in Indian currency as per conversion rate applicable on the date of payment through the SWIFT. Code: HDFCINBBXXX.
5. Tuition Fee& Hostel Fee:- Tuition fee is payable annually and charged for 4.5 years, the Hostel Charge is payable annually and is charged for 5½ years or duration of stay whichever is later. Students staying in hostel for more than the duration of the course either to failure in examination or extension of residency or any other reason shall be required to pay additional Hostel charge for their additional stay.
6. Refundable Security Deposit :- Refundable Security Deposit is payable once at the time of admission and will be refunded on completion of internship after deducting damages/dues as the case may be.
- 7)Bank Guarantee / Bond: The candidate shall also have to furnish Bank Guarantee/Bond for payment of tuition and development fees for the remaining period of the course at the time of the admission while paying the fee for 1st year through Bank Draft/RTGS/NEFT.
