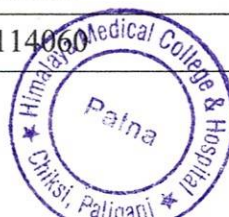

Terms / Notes:

1. The above fee structure shall be applicable to students admitted to the 1st Year MBBS Course during the Academic Session 2026-27 under UGMAC-2026.
2. The fee may be revised in accordance with any order/direction issued by the Educational Fee Fixation Committee, Bihar or other applicable statutory/regulatory authority.
3. NRI tuition fee shall be payable either in USD or the equivalent amount in Indian Rupees at the conversion rate applicable on the date of payment. Foreign currency remittance may be made through SWIFT Code: HDFCINBBXXX.
4. Tuition fee is payable annually and is charged for 4.5 years. Hostel and Mess Fee is payable annually and is charged for 5½ years or for the duration of stay, whichever is later. Students staying in the hostel beyond the normal duration of the course due to failure in examination, extension of study/residency, or any other reason shall pay the applicable hostel charges for such additional stay.
5. The Refundable Security Deposit is payable once at the time of admission and shall be refunded after completion of internship, subject to adjustment/deduction of damages, outstanding dues or other recoverable amounts, if any.
6. At the time of admission, the candidate shall also furnish the prescribed Bank Guarantee/Bond, wherever applicable, towards payment of fees for the remaining period of the course in accordance with the applicable admission requirements.
